The ORGANIZER may provide to Exhibitors, against additional payment (outside of the Price for the main services) the construction and the use of additional equipment and props (requisite), including, but not limited to tents and bungalows, window displays, furniture, branding, landscaping, etc. which are negotiate separately.

II. PAYMENT TERMS AND DISCOUNTS

- **1. Acceptance of the Participation application** it is considered accepted upon payment of an advance payment within 5 working days after registration and signing of this Application contract for participation.
- 2. Selection of a place within the exhibition according to the order of payments received, the exhibitors get access to the current scheme with free areas and choose their position.
- 3. Discounts (not valid for Zone 1) -40° % discount on the prices of the exhibition areas upon payment by January 15, 2026; 20% discount upon payment by February 27, 2026; 40% discount on the prices of the areas for new exhibitors or companies that have not participated in the Exhibition within 5 years prior to this online application.

Stand construction, equipment and additional services are subject to 25% discount in case they are ordered and paid not later than February 27, 2026.

4. Payments - advance payment in the amount of 30% of the value of the area + 100% Service Fee; additional payment - 70% of the value of the area. Final date for all payments: April 17, 2026.

III. RIGHT OF PARTICIPATION AND CANCELLATION TERMS

- 1. Reduction of the areas, withdrawal from participation, rescission or termination of the contract by the Exhibitor: No later than 45 days before the opening date of the Exhibition, and in case of withdrawal from participation, termination or rescission of the contract within this period, a penalty in the amount equal of the advance payment is charged. If the areas are reduced within the same period, a penalty is retained in the amount of the advance payment for the canceled exhibition area, in case the areas are reduced by more than 20% of the originally requested. In case of non-compliance with the specified period of 45 days, the Exhibitor owes a penalty for termination/ rescission of the contract in the amount of the contract price together with the value of the requested additional services.
- 2. Admission of the participation of Exhibitors by the Organizer if the following conditions apply:
- Exhibitors carry out production and/or commercial activity permitted by law in accordance with the branch categories defined by the Exhibition;
- Exhibitors present a proper and valid for the relevant year in which the Exhibition is held, a Manufacturer's authorization for the Exhibitor to offer the goods and services claimed as exhibits, and maintain the authorization for the period of the Exhibition, where relevant;
- Exhibitors present and have presented only new and unused items or agricultural equipment at the current or previous Exhibitions under the 'BATA AGRO' trademark, which are directly related to agricultural mechanization and activity at the current or previous Exhibitions under the 'BATA AGRO' trademark;
- -Exhibitors comply with the rules for: participation and holding of the exhibition, release and preservation of the used space and facilities, the rules of safety and environmental compliance or the instructions of the Organizer and fulfill their obligations to the Organizer. In the event that an Exhibitor has not complied with any of the stated conditions of the current or previous Exhibition, the Organizer has the right not to allow him to participate in the Exhibition or to remove him from participation in the Exhibition.

IV. IMPORTANT TERSM AND DOCUMENTS

- 1. BATA AGRO 2026 Exhibition period: from June 1 to 5, 2026.
- 2. Deadlines for installation, dismantling and working hours of the exhibition:
- Installation of stands from 11th May to 31th May, 2026- from 08:00 to 20:00h.
- Accommodation of the Exhibitors and arrangement of exhibits from 25th May to 31th May, 2026 from 08:00 to 20:00h.
- WORKING HOURS for visitors from 09:00 to 18:00h in the period 1st 4th June and until 14:00h on the 5th of June, 2026.
- $WORKING\ HOURS\ for\ exhibitors\ in\ the\ days\ of\ the\ Exhibition\ -\ from\ 08:00\ to\ 19:00h.\ Loading\ of\ stands,\ entry\ of\ cars\ and\ other\ vehicles$
- from 08:00 to 08:45h, by 09:00h all motor vehicles should have left the exhibition area.
- Release of the occupied area and dismantling of all facilities of stands from 6th to 10th June, 2026 from 08:00 to 20:00h. For stands built by the Organizer, the deadline for releasing is until 6th June, 2026 inclusive.

On the last day of the exhibition, 5th of June, after 16:00h, it is permissible to take out equipment and exhibits by self-propelled course or to take out materials that can be loaded manually, without the use of any vehicles or loading/unloading equipment.

- During the entire period of the Exhibition, it is not permitted for equipment or exhibits to be taken out.

3. Mandatory documents and data to be provided to the Organizer:

- 3.1. Valid declaration by the Manufacturer for active authorization of the Exhibitor to sell the relevant exhibits and trademarks on the territory of Bulgaria by 17th April, 2026 at the latest.
- 3.2. Insurance policies for property and persons operating on behalf of the Exhibitor, as well as insurance policies for liability to third parties by 20th May, 2026 at the latest.
- 3.3. Work projects and information about the stands not built by the Organizer by 30th April, 2026 at the latest. A deposit of EUR 500 is required for each such stand, which guarantees the correct exploitation of the area.
- 3.4. Filling in information for the Online Catalog of BATA AGRO participants through the Exhibitor's profile in the reservation system until 01st April, 2026. After that date, the catalog becomes public.

V. LIABILITY AND PENALTIES

- 1. In case of violation of the boundaries of the area, the price for the corresponding quadrature shall be paid in triple amount.
- 2. In case of presentation of used exhibits a penalty in the amount of five times the value for the area used.
- 3. In case of premature removal of exhibits or dismantling of equipment, as well as in case of non-compliance with the specified rules and regulations, the Organizer imposes a penalty of up to EUR 1,500 at its discretion (unless the damages caused do not exceed the fine).
- 4. In the case of unremoved equipment, fasteners or waste after the deadline for vacating the area a penalty in the amount of EUR 1,500.
- 5. In case of non-compliance with the announced working hours: EUR 100 per hour are charged for the overtime committed, additional rent for the area and facilities, the cost of additional security and cleaning are charged.

By signing this Application form - contract for participation, the Exhibitor agrees to the General Terms and Conditions for participation in the Exhibition, which are published on the Organizer's website and are considered an integral part of this contract.

The Application is irrevocable and binding for the Exhibitor and withdrawal can only be considered under the conditions specified in Art 1 of the General Terms and Conditions.

In the event of a dispute regarding the Exhibition or a dispute regarding the performance, existence, termination of the participation contract, on which an agreement is not reached through negotiations, the dispute shall be referred to the Court of Arbitration with the Bulgarian Chamber of Commerce and Industry in the city of Sofia.

This contract has been signed in two identical counterparts, one for each Party, and in case of a signed version in English language, the Bulgarian version of the text shall prevail for the purpose of interpreting the intentions of the parties.
